



The 2010 edition of the African Economic Outlook (AEO)



The 2010 African Economic Outlook was launched at the African Development Bank's annual meeting in Abidjan, Côte d'Ivoire on 24th May 2010. This year's edition finds the continent reeling from the effects of the world's deepest and most widespread recession in half a century. Many countries are at risk of falling far off track to achieving the Millennium Development Goal of halving extreme poverty and hunger by 2015. The good news is that the region has proved remarkably resilient to the downturn. Average growth is expected to rebound in 2010 and 2011, although the recession will leave its mark. In this neat two-pager, Terry McKinley, Director of the School of Oriental and African Studies, University of London concludes that: "despite having recently raised expectations about reforms in its fundamental policy stance, the IMF remains a long way from jettisoning the neoliberal underpinnings of its governing macroeconomic framework".

Cluster munitions

The UK has become the 32nd country to ratify the Convention on Cluster Munitions (see <http://www.clusterconvention.org/>). The instrument of ratification was deposited at the UN in New York on 4th May 2010. The treaty will now enter into force for the UK on 1 November 2010. The Convention is recognised as one of the most significant disarmament treaties of recent years, prohibiting the use, production, transfer and stockpiling of cluster munitions. The Cluster Munitions (Prohibitions) Act 2010 (http://www.opsi.gov.uk/acts/acts2010/ukpga_20100011_en_1) which received Royal Assent on 25 March 2010, implements the UK's international obligations under the treaty.

Black Sea policies

Democracy and good governance in the Black Sea Region

The fourth policy report of the Commission on the Black Sea on 'Democracy and Good Governance in the Black Sea Region' by Franz-Lothar Altmann, Johanna Deimel and Armando Garcia Schmidt has been released. Available from: <http://www.blackseacom.eu/policy-reports/>.

The authors assess the quality of the existing democratic institutions and identify common structures in the political and societal development of the Black Sea region by comparing ten countries: Bulgaria, Romania, Turkey, Greece (the consolidated west and south of the region); Armenia, Azerbaijan, Georgia and Moldova (the conflict-ridden states); and Russia and Ukraine. Based on this cross-national comparison the authors present a series of policy recommendations touching upon state aid and civil society support inter alia.

A 2020 vision for the Black Sea

The Commission has sought in this vision document to promote an inclusive strategy taking into account the needs, priorities and interests of all stakeholders in four essential areas: peace and security, economic development and welfare, democratic institutions and good governance and, finally, regional cooperation. The Commission has come to an understanding that the region's future lies in further democratisation and economic integration with the wider world. On civil society the Commission says: "The involvement of civil society in policy making and their linkages in relation to good governance should be encouraged. Efforts should also be made to facilitate cooperation between civil society organisations in Black Sea countries including the conflict regions. Business organisations such as chambers of commerce, employers' organisations and trade unions should also be encouraged to talk to one another in order to find and propose regional solutions for common problems".

The Commission on the Black Sea is a civil society initiative, jointly developed and launched in 2009 by the Bertelsmann Stiftung, Gütersloh; the Black Sea Trust for Regional Cooperation (BST - GMFUS), Bucharest; the Economic Policy Research Foundation of Turkey (TEPAV), Ankara; and the International Centre for Black Sea Studies (ICBSS), Athens. Among members of the Commission on the Black Sea are a former vice prime minister, former ministers, current and former parliamentarians, public intellectuals and scholars from the whole Black Sea region, the European Union and the United States.
