**Opening Session of the 2010 Joint World Conference**



For the first time this century the International Association of Schools of Social Work (IASSW), International Council on Social Welfare (ICSW) and International Federation of Social Workers (IFSW) combined their conferences. The success we achieved was not just the numbers - more than 2,500 conference participants from 113 countries. June 2010 marked the first time in living memory that the three organisations representing social work and social development worked together to develop a shared global agenda and action programme to promote social development and social justice.

In the grand opening ceremony Mr Sha Zukang, Under-Secretary-General for Economic and Social Affairs at the United Nations warmly endorsed the combined commitment by IASSW, ICSW and IFSW to a common agenda. Mr. Sha emphasised the global significance of the conference for the UN and the world.

He issued a call to action to those working in social development to foster partnership between IFSW, IASSW and ICSW and United Nations. Mr. Sha noted that “This is the first civil society gathering abroad that I have attended in my capacity as Under-Secretary-General... You, however, as a group of social workers and social development experts are truly a special audience. You work with the poor, the voiceless, the disenfranchised. Too often, you are not properly acknowledged. I wish to state, here and now, that the United Nations recognizes your contributions, day by day and village by village, to achieving the lofty development goals established in UN conference rooms in New York. Thank you.”

Mr. Sha said that the three organisations “were among the first non-governmental organizations to acquire consultative status with the UN Economic and Social Council. For more than half a century, they have made strong contributions to UN achievements in social progress.”

He went on to say, “You represent an astounding range of expertise in the field of social work and development.... This breadth and depth of expertise motivates me in my own role as a senior UN official in charge of economic and social affairs. It gives me hope that through our collective efforts we can reduce the staggering levels of poverty, social injustice and exclusion that exist today.” Mr. Sha issued many challenges to the conference and to IASSW, ICSW and IFSW. He sought our support for the achievement of the MDGs; he invited the three organisations to contribute to the success of the Rio+20 Summit; he asked us to assist the UN in communications and promotions; he asked for our assistance in reaching out to NGOs in Southern countries. Mr. Sha said “I therefore applaud the message of this Conference: Together we build the agenda; Together we face the challenges: Together we thrive.”

## Building the Agenda

## Social Protection Floor Initiative (SPFI)



The preconference workshop on the SPFI was very successful. Key policy makers were introduced to the concepts and practices of social protection. It was followed later in the conference by a plenary on social protection led by speakers from the UN Department of Economic and Social Affairs (UNDESA), UNICEF and OECD POVNET

In April 2009, the UN Chief Executives Board (CEB) launched a social protection floor as one of its 9 initiatives to cope with the global crisis. ICSW adopted the SPFI as its major policy initiative in 2010 and 2011 and added it to its Global Programme. In adopting the SPFI the General Assembly of ICSW members resolved to ask each the nine ICSW regions to make the SPFI a key part of their social policy agenda and engage national and regional governments in issues surrounding the model, adoption, implementation and sustaining of the SPFI. ICSW will work to have civil society become members of joint SPFI taskforces. The General Assembly asked that ICSW participates in global discussions on the SPFI and channel knowledge and opportunities to IASSW and IFSW. ICSW offered to act as a clearing house for knowledge and resources for IASSW, ICSW and IFSW. Soon the home page of the ICSW website will feature a special link to the SPFI.

### What are the concepts underlying the SPFI?

The Social Protection Floor corresponds to a set of basic social rights, services and facilities that a citizen should enjoy. It can be seen as a core obligation to ensure the realisation of minimum essential levels of rights embodied in human right treaties. The Social Protection Floor could consist of 2 main elements that help to realise these human rights:

1. **Ensuring the availability, continuity, and geographical and financial access to essential services**, such as water and sanitation, food and adequate nutrition, health, education, housing and other social services such as life and asset saving information.
2. **Realising access by ensuring a basic set of essential social transfers**, in cash and in kind, to provide a minimum income and livelihood security for poor and vulnerable populations and to facilitate access to essential services. It includes social transfers (but also information, entitlements and policies) to children, people in active age groups with insufficient income and older persons

The SPFI promotes a holistic and coherent vision of national social protection systems as a key component of national development strategies. It seeks to support countries in identifying and closing crucial protection gaps through coherent and efficient measures that maximise the effects of scarce resources on the reduction of poverty and insecurity, to ensure “guaranteed access” to essential services and social transfers.
